RE: Community-Wide House Painting

Dear fellow Coral Trace Homeowners,

We want to first thank you for all you do to make Coral Trace a wonderful place to live. There are some original owners still with us, as well as many new additions to our community. We appreciate all your efforts to keep our little slice of South Florida nice.

Part of our regular upkeep is repainting the exterior of our homes to keep them fresh and clean. This includes painting all exterior walls, trim, doors, entry ways, patios, and wooden fences. 2022 is the year we are scheduled to accomplish this community-wide painting project.

As a board, we have worked to make the process as easy as possible. In the following pages you will find updated language to clarify the responsibilities of each owner as well as the information needed to be successful. Again, our goal is to make it as simple as possible for all.

Please read the following information carefully The answers to most questions should be found in this packet

Please note that the following information, procedures, and rules fully replaces and supersedes any prior house colors and/or painting rules.

Official notification of the intended rule change, the current relevant rules, and updated rules are included in this information packet.

The painting project will begin on March 1, 2022. All homeowners shall have their homes painted no later than May 31, 2022.

In preparation for painting, we ask all homeowners to remove all vines or hanging plants that are attached to the exterior walls. Please also double check that all outdoor plants are trimmed away from the walls. Doing these prep steps will ensure full paint coverage.

One of the founding fundamentals of our community is a consistency of home colors. There are three colors combinations we use: sand, pink, and salmon. For simplicity each address is listed on the following pages with the current home color. On the bottom of each page is the specific brand of paint, sheen, color formulation, etc. that is used for those homes.

Our only approved paint brand is Sherwin-Williams. "Color Matching" or the use of brands or finishes other than those outlined below is not permitted.

Each homeowner can simply present the appropriate page with their address to either of the two Sherwin-Williams stores in Delray Beach to purchase the approved paint type and current color formula. In doing so we will maintain a pleasant color uniformity.

To help reduce the cost of paint, we have established a discount with the two Sherwin-Williams Delray Beach stores. Our discount account number is: 3354-9787-1

NOTE: This account number only provides a discount. The homeowner pays for their own paint either directly to the store or through their contractor.

All homeowners are free to either paint their homes themselves or hire a professional painting contractor. While some may already know a painting contractor they would like to use, there are others that may not. In an effort to make the process as simple as possible, we have prescreened the following painting companies. This means simply they 1) were provided with our community painting rules and they agreed to abide by our requirements and 2) have been previously used in the community with positive results or have a number of positive reviews in online searches.

To be clear, the Coral Trace Homeowners Association, Inc. does not recommend, endorse, or encourage the use of any company. Hiring a contractor is solely at the discretion of the homeowner. Any agreement between the homeowner and contractor is unique to them and shall not involve the Coral Trace Homeowners Association, Inc. or the Board of Directors in any way.

The homeowner is ultimately and solely responsible to ensure the proper paint brand, sheen, color formula, as well as all other information outlined on the following pages are followed. Any prices listed below are simply recent estimates provided by the companies; they are not

intended to be a guaranteed, set, or fixed price. The final price, including the addition of painting fences, repairs, etc., remains solely between the homeowner and any contractor they may hire.

Coral Trace includes three models of homes. The estimates we received are for a single home, not the entire building. We are told that both companies listed below include pressure cleaning exterior walls, masking/covering surfaces as needed, window/surface caulking as needed, and a single coat of paint on the main home structure. Fences or other requests are additional.

Angle Wing – Either side of the buildings including two homes (double) \$1890 - \$2500

Periwinkle – The end homes of buildings with four homes (quads) \$1780 - \$2350

Coquina – The center homes of buildings with four homes (quads) \$1640 - \$1800

HOUSE PAINTING / COLOR (REVISED 2/28/2022)

The following text outlines the updated House Colors / Painting Rules as revised on 2/28/2022 and is intended by the Association's Board of Directors to be in full force and effect as of that date and fully replaces and supersedes any prior House Colors / Painting Rules.

Coral Trace homeowners are responsible for the upkeep, cleaning, and painting of their own home exterior. Through this effort we all help maintain the clean look of our neighborhood.

The Coral Trace community was founded upon standardized colors for a consistent appearance. This is accomplished by using a uniform paint brand, paint sheen, and specific color formulas. Each owner is required to use the specific information provided in the following pages for their individual address. Painting includes all exterior walls, entry ways, doors, and wooden fences.

<u>Painting Frequency</u>: Exposure to the elements necessitates our homes be repainted on occasion. Each homeowner will repaint their home, at their own expense, in a community-wide project every 10 years. The years for painting are 2012, 2022, 2032, etc. The Board will advise of the specific months for painting at that time.

<u>Paint Color</u>: For the ease and convenience of the homeowners, each address within our community is listed on the attached pages with the required paint brand, sheen, and color formulation for their individual home. If an owner wishes to use a professional painting contractor, the owner is solely responsible for, and ensures the contractor uses only the approved paint and color formula. "Color matching" and/or using other brands, sheens, or color formulas is not permitted.

General Paint Information:

Brand: Sherwin-Williams Type: Super Paint Exterior Latex

Sheen: Satin for both the Stucco Main and Stucco Trim colors

Fascia Trim: White Glossy Latex Garage and Front Door: White

Rain Gutters: White Down Spouts: White or Stucco Main Color

Wood Fences: White

Cost of painting: Each homeowner is responsible for the cost of painting their individual home.

Sherwin-Williams Discount: Sherwin-Williams is the only approved paint brand.

<u>Paint Violations</u>: Any homeowner who paints their home in a non-conforming color, brand, sheen, etc., or if a home is deemed to require painting in between the outlined painting years, as determined in the sole discretion of the Association's Board of Directors, shall, upon demand of the Association, cause the home to be re-painted with the conforming color, brand, sheen, etc. The Association is empowered to enforce the painting provisions of the Resident Handbook, by any legal or equitable remedy. Specifically, in the event that it becomes necessary to resort to litigation due a homeowner's non-compliance, the Association shall be entitled to recover court costs, expenses and attorneys' fees and paraprofessional fees, pretrial and at all levels of proceedings, including appeals.
