## **Hotwire Status Update #6 and Next Steps**

### **Update 9-7-2022**

Hello Fellow Coral Trace Homeowners and Residents:

#### **ROLL-OUT SCHEDULE:**

Included below with this email is a 3-page Coral Trace – Hotwire Rollout Schedule. The listing is sorted by house number, followed by direction (N, S, E, W) then by suffix (Cir, Ln, Ct, Pl). Next you will find the Release Date for the segment that each home is on. Note: the segments are not defined by a street or area within the community. Therefore, a home across the street from you may be on a different segment and have a different activation date.

Hotwire has already begun contacting homeowners and residents, who have already completed their initial consultation and set up an account, to schedule their White-Glove In-Home Fision TV and Internet Services installations. Scheduling is based on the Release Dates within the Coral Trace - Hotwire Rollout Schedule.

**As we move into the In-Home installation process, and as part of Hotwire's committed White-Glove Service throughout the next phase, a technical resource person will be stationed in our clubhouse from 10a–5p on Mon–Wed–Fri, and from 11a–7p on Tue & Thu. Should you have a question or need help with the new functionality after your installer is finished, feel free to visit the on-site person.**

#### **A FEW REMINDERS:**

**What You Must Do Before Having Your Home's Installation Scheduled:**

**IMPORTANT:** If you have not done so **immediately schedule a One-on-One consultation** by calling **561-509-5429**. The meeting can be either in person or virtually.

**If you are a Landlord:**

It is in your best interest to make arrangements with your tenant to schedule a consultation to set up an account and approve the installation and location(s) for the service lines and hardware within your unit. The Hotwire installation costs to bring the service into your home after the initial community install will cost you \$250 or more. Do not miss this opportunity.

**If you are a Renter:**

You **MUST** receive approval from your landlord to schedule and approve the installation of the service and equipment in your home. Hotwire may ask you to confirm that you have an active lease before scheduling the installation.

**Seasonal Owners:**

**Even though you may not be in the community, You need to schedule your One-on-One Consultation.** Once you receive notice from Hotwire that they are ready to install in your home, you should contact them to let them know when you anticipate returning and schedule your installation.

**Landline Phone Users Wanting to Keep Your Phone Number:**

**Remember, if you have a current phone number that you want to port over to Hotwire, do not cancel your current provider's phone service until the Hotwire Installation Technician tells you to do so!**

**ONCE YOU ARE ON THE HOTWIRE PLATFORM AND HAVE CONFIRMED THAT IT IS OPERATIONAL, REMEMBER TO CONTACT YOUR CURRENT SERVICE PROVIDER TO CANCEL SERVICES THAT YOU WILL BE RECEIVING FROM HOTWIRE. ALSO MAKE ARRANGEMENTS TO RETURN ALL RENTED EQUIPMENT! WHEN CANCELING YOUR EXISTING SERVICES, ASK YOUR CURRENT PROVIDER TO CONFIRM YOUR PRORATED FINAL BILL BALANCE AND ANY DUE CREDITS THAT YOU MAY BE OWED.**

**OTHER RELATED UPDATES:**

**On-Going Hotwire Work:**

The Hotwire Splicing Team continues to be working throughout the community to connect the fiber lines leading all the way up to each individual home. So please DO NOT be alarmed if you should see someone

**ALL HOTWIRE EMPLOYEES CAN BE IDENTIFIED BY EITHER A GRAY OR WHITE HOTWIRE SHIRT, OR CONSTRUCTION VESTS/SHIRTS.**

**Construction Update/Reminder:**

Except for returning to address Hotwire related activation issues, the construction (Trenching and Tunneling) phase of the Hotwire implementation is now complete. At this point, if you discover a broken irrigation line or sprinkler along the trenching areas, you should create a work order by calling Seacrest or online via [seacrestservices.com](https://seacrestservices.com).

If you left the community prior to the trenching and are returning to the community to find that your Xfinity to AT&T content service(s) were disrupted, you should place a call directly to your provider's support number.

In a few weeks, Hotwire's Construction Team be returning to our community to perform a walkthrough for repairing the landscaping along the trench lines around the lakes and through the utility easements, which may not have recovered from the digging.

Due to the number of concurrent installations that will be occurring throughout the community over the coming weeks, Hotwire employees will be using our pool area and guest parking locations for their personal vehicles while on site. We appreciate your patience and understanding for any parking challenges that may result from this effort. Please continue to look for additional updates and communications from the HOA and/or Hotwire as this project continues through the final stages

It is exciting to see that the benefits of the Hotwire Fision TV and Internet community agreement are about to be realized throughout the community. Many who have already had their Hotwire Consultations have commented positively on their experiences to date, and anticipated savings once they migrate over to the new platform.
